- 1. Sick Leave Policy: Motion by Sawin, supported by Ransom to update the MCD sick leave policy to the MACD sick leave policy template to reflect the new state law. Motion passed.
- 2. Forest Area Credit Union Account: Motion by Ransom, supported by Sawin to designate Susanna Schwager as the signer to close the Missaukee Conservation District's Forest Area Credit Union account. Motion passed.
- 3. Certificate of Deposit: Motion by Nyce, supported by Ransom to move the money from the Forest Area Credit Union account into the Huntington Bank account and use that money plus money from the Huntington Bank account to open a Certificate of Deposit in the amount of \$20,000 at Huntington Bank. Motion passed.
